## **S1 Survey Questionnaire**

This Appendix includes the survey questionnaire. Participants were recruited into the study using the web survey service CloudResearch which aggregates participants from multiple online survey platforms. CloudResearch worked with the research team to target Republican and Democrat participants who were representative of the demographics of each respective party. The survey and research protocols were approved by the Institutional Review Boards (IRB) at UCLA, University of Toronto, and Columbia University.

### **S1.1 Study Information Sheet**

#### Survey Instructions

Thank you for agreeing to take this survey. It is very important for the success of our research project that you complete the survey until the end, once you have started. This survey should take (on average) about 10 minutes to complete.

The survey requires the ability to listen to audio clips through SoundCloud – please make sure that your browser will be able to do this before you begin.

#### Why is this study being done?

Researchers at UCLA (Emily Weisburst), the University of Toronto (Carolina Arteaga) and Columbia University (Hassan Afrouzi) are conducting a study about media, politics and perception. Your participation in this research study is voluntary.

#### What will happen if I take part in this research study?

If you volunteer to participate in this study, the researcher will ask you to do the following: Answer a few questions about your demographics and political/social views and listen to an audio clip of a speech.

#### Who can participate in the study?

The focus of this study is understanding people's views on social issues for individuals in particular groups. We are seeking participation from English speakers who are eligible to vote in the U.S. and who have certain social/political views.

#### How long will I be in the research study?

Participation will take a total of about 10 minutes. If you complete the survey, the researchers may contact you to participate in a follow-up survey at a later date.

#### Are there any potential benefits, risks or discomforts that I can expect from this study?

There are no anticipated benefits. There are no anticipated risks or discomforts.

### Will I be paid for participating?

You will receive compensated according to the terms and conditions agreed to when you joined your panel.

### What are the features of the lottery payment in the survey?

As part of the study, there will be a lottery where participants can earn up to \$25 in addition to the base compensation for participation. Survey participants do not need to complete the entirety of the survey or remain in the study to be entered into the drawing for \$25. The probability of winning the lottery is approximately 0.01%. If you win the lottery, you will be notified at the conclusion of the survey and will be paid within 2 months. You may need to share additional contact information in order to receive payment.

## S2 Speech Treatments

This section includes the full text of the audio excerpts used as treatments in the experiment as well as the original speeches that the excerpts were derived from. We also include links to the audio treatments used in the experiment as well as video versions of the original speeches.

### S2.1 President Trump: Full Immigration Speech

*Below is the text of the full speech on immigration given by President Trump on 1/19/2019. The speech was given as part of a public effort to end a government shutdown related to immigration policy negotiations. In the speech, Trump offers to provide protection for children who came to the U.S. illegally (through the Deferred Action for Childhood Arrivals or DACA program) as part of an exchange for additional funding for border security. The sentences are numbered so that it is easier to see how the excerpted segments used in the experiment were constructed.*

[1] Just a short time ago, I had the honor of presiding over the swearing in of five new great American citizens. [2] It was a beautiful ceremony and a moving reminder of our nation's proud history of welcoming legal immigrants from all over the world into our national family. [3] I told them that the beauty and majesty of citizenship is that it draws no distinctions of race or class or faith or gender or background. [4] All Americans whether first generation or tenth generation are bound together in love and loyalty, friendship and affection. [5] We're all equal. [6] We are one team and one people proudly saluting one great American flag.

[7] We believe in a safe and lawful system of immigration, one that upholds our laws, our traditions and our most cherished values. [8] Unfortunately, our immigration system has been badly broken for a very long time. [9] Over the decades many presidents and many lawmakers have come and gone, and no real progress has been made on immigration. [10] We are now living with the consequences – and they are tragic – brought about by decades of political stalemate, partisan gridlock, and national neglect.

[11] There is a humanitarian and security crisis on our southern border that requires urgent action. [12] Thousands of children are being exploited by ruthless "coyotes" and vicious cartels and gangs. [13] One in three women is sexually assaulted on the dangerous journey north. [14] In fact, many loving mothers give their young daughters birth control pills for the long journey up to the United States because they know they may be raped or sexually accosted or assaulted. [15] Nearly 50 migrants a day are being referred for urgent medical care. [16] Vast quantities of lethal narcotics are flooding through our border and into our communities, including meth, cocaine, heroin and fentanyl.

[17] Drugs kill 78,000 Americans a year and cost our society in excess of \$700 billion. [18] Heroin alone kills 300 Americans a week; 90 percent of which comes across our southern border. [19] We can stop heroin.

[20] Illegal immigration reduces wages and strains public services. [21] The lack of border control provides a gateway, and a very wide and open gateway, for criminals and gang members to enter the United States, including the criminal aliens who murdered a brave California police officer only a day after Christmas. [22] I've gotten to know and love angel moms, dads and family who lost loved ones to people illegally in our country.

[23] I want this to end; it's got to end now. [24] These are not talking points. [25] These are the heartbreaking realities that are hurting innocent, precious human beings every single day on both sides of the border. [26] As a candidate for president, I promised I would fix this crisis, and I intend to keep that promise one way or the other. [27] Our immigration system should be the subject of pride, not a source of shame, as it is all over the world.

[28] Our immigration system should be the envy of the world, not a symbol of disunity and dysfunction. [29] The good news is these problems can all be solved, but only if we have the political courage to do what is just and what is right. [30] Both sides in Washington must simply come together, listen to each other, put down their armor, build trust, reach across the aisle and find solutions.

[31] It is time to reclaim our future from the extreme voices who fear compromise and demand open borders, which means drugs pouring in, human trafficking and a lot of crime. [32] That is why I am here today, to break the logjam and provide Congress with a path forward to end the government shutdown and solve the crisis on the southern border. [33] If we are successful in this effort, we will then have the best chance in a very long time at real bipartisan immigration reform. [34] And it won't stop here. [35] It will keep going until we do it all. [36] The proposal I will outline today is based, first and foremost, on input from our border agents and Homeland Security professionals – and professionals they are; they know what they're doing.

[37] It is a compassionate response to the ongoing tragedy on our southern border. [38] In recent weeks we have met with large numbers of Democrat lawmakers to hear their ideas and suggestions. [39] By incorporating the priorities of rank and file Democrats in our plan, we hope they will offer their enthusiastic support. [40] And I think many will.

[41] This is a common-sense compromise both parties should embrace.

[42] The radical left can never control our borders. [43] I will never let it happen. [44] Walls are not immoral. [45] In fact, they are the opposite of immoral, because they will save many lives and stop drugs from pouring into our country. [46] Our plan includes the following: \$800 million in urgent humanitarian assistance; \$805 million for drug detection technology to help secure our ports of entry. [47] An additional 2,750 border agents and law enforcement professionals, 75 new immigration judge teams to reduce the court backlog of - believe it or not - almost 900,000 cases. [48] However, the whole concept of having lengthy trials, for anyone who sets one foot in our country unlawfully, must be changed by Congress.

[49] It is unsustainable. [50] It is ridiculous. [51] Few places in the world would even consider such an impossible nightmare. [52] Our plan includes critical measures to protect migrant children from exploitation and abuse.

[53] This includes a new system to allow Central American minors to apply for asylum in their home countries, and reform to promote family reunification for unaccompanied children, thousands of whom wind up on our border doorstep. [54] To physically secure our border, the plan includes \$5.7 billion for a strategic deployment of physical barriers, or a wall. [55] This is not a 2,000 mile concrete structure from sea to sea. [56] These are steel barriers in high priority locations.

[57] Much of the border is already protected by natural barriers, such as mountains and water. [58] We already have many miles of barrier, including 115 miles that we are currently building or under contract. [59] It will be done quickly. [1] My fellow Americans, tonight, I'd like to talk with you about immigration.

[2] For more than 200 years, our tradition of welcoming immigrants from around the world has given us a tremendous advantage over other nations. [3] It's kept us youthful, dynamic, and entrepreneurial. [4] It has shaped our character as a people with limitless possibilities – people not trapped by our past, but able to remake ourselves as we choose.

[5] But today, our immigration system is broken, and everybody knows it. [6] Families who enter our country the right way and play by the rules watch others flout the rules. [7] Business owners who offer their workers good wages and benefits see the competition exploit undocumented immigrants by paying them far less. [8] All of us take offense to anyone who reaps the rewards of living in America without taking on the responsibilities of living in America. [9] And undocumented immigrants who desperately want to embrace those responsibilities see little option but to remain in the shadows, or risk their families being torn apart.

[10] It's been this way for decades. And for decades, we haven't done much about it.

[11] When I took office, I committed to fixing this broken immigration system. [12] And I began by doing what I could to secure our borders. [13] Today, we have more agents and technology deployed to secure our southern border than at any time in our history. [14] And over the past six years, illegal border crossings have been cut by more than half. [15] Although this summer, there was a brief spike in unaccompanied children being apprehended at our border, the number of such children is now actually lower than it's been in nearly two years. [16] Overall, the number of people trying to cross our border illegally is at its lowest level since the 1970s. [17] Those are the facts.

[18] Meanwhile, I worked with Congress on a comprehensive fix, and last year, 68 Democrats, Republicans, and Independents came together to pass a bipartisan bill in the Senate. [19] It wasn't perfect. [20] It was a compromise, but it reflected common sense. [21] It would have doubled the number of border patrol agents, while giving undocumented immigrants a pathway to citizenship if they paid a fine, started paying their taxes, and went to the back of the line. [22] And independent experts said that it would help grow our economy and shrink our deficits.

[23] Had the House of Representatives allowed that kind of a bill a simple yes-or-no vote, it would have passed with support from both parties, and today it would be the law. [24] But for a year and a half now, Republican leaders in the House have refused to allow that simple vote. [25] Now, I continue to believe that the best way to solve this problem is by working together to pass that kind of common sense law. [26] But until that happens, there are actions I have the legal authority to take as President – the same kinds of actions taken by Democratic and Republican Presidents before me – that will help make our immigration system more fair and more just.

[27] Tonight, I am announcing those actions. [28] First, we'll build on our progress at the

border with additional resources for our law enforcement personnel so that they can stem the flow of illegal crossings, and speed the return of those who do cross over.

[29] Second, I will make it easier and faster for high-skilled immigrants, graduates, and entrepreneurs to stay and contribute to our economy, as so many business leaders have proposed.

[30] Third, we'll take steps to deal responsibly with the millions of undocumented immigrants who already live in our country. [31] I want to say more about this third issue, because it generates the most passion and controversy. [32] Even as we are a nation of immigrants, we are also a nation of laws. [33] Undocumented workers broke our immigration laws, and I believe that they must be held accountable – especially those who may be dangerous. [34] That's why, over the past six years, deportations of criminals are up 80 percent. [35] And that's why we're going to keep focusing enforcement resources on actual threats to our security. [36] Felons, not families. [37] Criminals, not children. [38] Gang members, not a mother who's working hard to provide for her kids. [39] We'll prioritize, just like law enforcement does every day.

[40] But even as we focus on deporting criminals, the fact is, millions of immigrants – in every state, of every race and nationality – will still live here illegally. [41] And let's be honest – tracking down, rounding up, and deporting millions of people isn't realistic. [42] Anyone who suggests otherwise isn't being straight with you. [43] It's also not who we are as Americans. [44] After all, most of these immigrants have been here a long time. [45] They work hard, often in tough, low-paying jobs. [46] They support their families. [47] They worship at our churches. [48] Many of their kids are American-born or spent most of their lives here, and their hopes, dreams, and patriotism are just like ours.

[49] As my predecessor, President Bush, once put it: “They are a part of American life.”

[50] Now here's the thing: we expect people who live in this country to play by the rules. [51] We expect that those who cut the line will not be unfairly rewarded. [52] So we're going to offer the following deal: If you've been in America for more than five years; if you have children who are American citizens or legal residents; if you register, pass a criminal background check, and you're willing to pay your fair share of taxes – you'll be able to apply to stay in this country temporarily, without fear of deportation. [53] You can come out of the shadows and get right with the law.

[54] That's what this deal is. [55] Now let's be clear about what it isn't. [56] This deal does not apply to anyone who has come to this country recently. It does not apply to anyone who might come to America illegally in the future. [57] It does not grant citizenship, or the right to stay here permanently, or offer the same benefits that citizens receive – only Congress can do that. [58] All we're saying is we're not going to deport you.

[59] I know some of the critics of this action call it amnesty. [60] Well, it's not. [61] Amnesty is the immigration system we have today – millions of people who live here without paying their taxes or playing by the rules, while politicians use the issue to scare people and whip up votes at election time. [62] That's the real amnesty – leaving this broken system the way it is.

[63] Mass amnesty would be unfair. [64] Mass deportation would be both impossible and contrary to our character. [65] What I'm describing is accountability – a commonsense, middle ground approach: If you meet the criteria, you can come out of the shadows and get right with the law. [66] If you're a criminal, you'll be deported. [67] If you plan to enter the U.S. illegally, your chances of getting caught and sent back just went up.

[68] The actions I'm taking are not only lawful, they're the kinds of actions taken by every single Republican President and every single Democratic President for the past half century.

[69] And to those Members of Congress who question my authority to make our immigration system work better, or question the wisdom of me acting where Congress has failed, I have one answer: Pass a bill. [70] I want to work with both parties to pass a more permanent legislative solution. [71] And the day I sign that bill into law, the actions I take will no longer be necessary. [72] Meanwhile, don't let a disagreement over a single issue be a dealbreaker on every issue. [73] That's not how our democracy works, and Congress certainly shouldn't shut down our government again just because we disagree on this. [74] Americans are tired of gridlock. [75] What our country needs from us right now is a common purpose – a higher purpose.

[76] Most Americans support the types of reforms I've talked about tonight. [77] But I understand the disagreements held by many of you at home. [78] Millions of us, myself included, go back generations in this country, with ancestors who put in the painstaking work to become citizens. [79] So we don't like the notion that anyone might get a free pass to American citizenship. [80] I know that some worry immigration will change the very fabric of who we are, or take our jobs, or stick it to middle-class families at a time when they already feel like they've gotten the raw end of the deal for over a decade. [81] I hear these concerns. [82] But that's not what these steps would do. [83] Our history and the facts show that immigrants are a net plus for our economy and our society. [84] And I believe it's important that all of us have this debate without impugning each other's character.

[86] It's about who we are as a country, and who we want to be for future generations. [87] Are we a nation that tolerates the hypocrisy of a system where workers who pick our fruit and make our beds never have a chance to get right with the law? [88] Or are we a nation that gives them a chance to make amends, take responsibility, and give their kids a better future? [89] Are we a nation that accepts the cruelty of ripping children from their parents' arms? Or are we a nation that values families, and works to keep them together? [90] Are we a nation that educates the world's best and brightest in our universities, only to send them home to create businesses in countries that compete against us? [91] Or are we a nation that encourages them to stay and create jobs, businesses, and industries right here in America? [92] That's what this debate is all about. [93] We need more than politics as usual when it comes to immigration; we need reasoned, thoughtful, compassionate debate that focuses on our hopes, not our fears. [94] I know the politics of this issue are tough. [95] But let me tell you why I have come to feel so strongly about it. [96] Over the past few years, I have seen the determination of immigrant fathers who worked two or three jobs, without taking a dime from the government, and at risk at any moment of losing it all, just to build a better life for their kids. [97] I've seen the heartbreak and anxiety of children whose mothers might be taken away from them just because they didn't have the right papers. [98] I've seen the courage of students who, except for the circumstances of their birth, are as American as Malia or Sasha; students who bravely come out as undocumented in hopes they could make a difference in a country they love. [99] These people – our neighbors, our classmates, our friends – they did not come here in search of a free ride or an easy life. [100] They came to work, and study, and serve in our military, and above all, contribute to America's success. [101] Tomorrow, I'll travel to Las Vegas and meet with some of these students, including a young woman named Astrid Silva. [102] Astrid was brought to America when she was four years old. [103] Her only possessions were a cross, her doll, and the frilly dress she had on. [104] When she started school, she didn't speak any English. [81] I hear these concerns.

[10] It's been this way for decades. And for decades, we haven't done much about it. [11] When I took office, I committed to fixing this broken immigration system. [12] And I began by doing what I could to secure our borders. [13] Today, we have more agents and technology deployed to secure our southern border than at any time in our history. [14] And over the past six



years, illegal border crossings have been cut by more than half.

[28] We'll build on our progress at the border with additional resources for our law enforcement personnel so that they can stem the flow of illegal crossings, and speed the return of those who do cross over.
